SECTION ONE

BOARD'S OVERVIEW AND MANDATE

1.1 Introduction

The Procurement and Supplies Professionals and Technicians Board (PSPTB) is a regulatory professional Board established by the Act of Parliament, CAP 179 of the laws of Tanzania to regulate the procurement and supply chain profession in the country. The Board is also mandated to provide professional advice and recognize all training institutions within the country offering courses in procurement and supply chain programs under the functions provided under section 7 of the PSPTB Act No. 23 of 2007 as highlighted here under;

- (a) To formulate and advise the government on overall policy relating to the profession of procurement and supply chain management
- (b) To plan, direct, coordinate, monitor and control personnel requirements in the procurement and supplies management profession;
- (c) To provide professional advice and recognize all trainings institutions within the country offering courses in procurement;
- (d) To formulate, establish and enforce the maintenance of standards of conduct and regulate the activities of procurement specialists, supplies professionals, procurements auditors, supplies and stock auditors, procurement technicians and supplies technicians and the practice of the profession of procurement and supplies management;
- (e) To train and provide opportunities for the training of persons in the principles, procedures and techniques of procurement and supplies management;
- (f) To conduct professional examinations leading to the grant of and to grant professional certificates and other awards of the Board in procurement, supplies, procurement audit, supplies and stock

auditing and other subjects relating to procurement and supplies management;

- (g) To effect registration of procurement and supplies professionals;
- (h) To keep and maintain a register for the registration of procurement and supplies professionals in accordance with PSPTB Act;
- (i) To evaluate academic and practical qualifications for the purpose of registration of persons under the PSPTB Act;
- (j) To sponsor, arrange and provide facilities for conferences, seminars, discussions, and consultations on matters relating to procurement and supplies management;
- (k) To prescribe fees payable to the PSPTB
- (l) To assist members of the public in matters touching upon, ancillary incidental or conducive to the practice of the profession of procurement and supplies management; and
- (m) To carry out such other functions as may be conferred upon the PSPTB by any written law or as are necessary or expedient for the proper carrying out of its functions under the PSPTB Act.

In that regard, the Board has developed this guideline to enhance quality standards for procurement and supply chain training programs in private and public training institutions in the country.

SECTION TWO

OVERVIEW OF CURRICULUM ACCREDITATION GUIDELINE

2.1 Introduction

This section provides an overview of the guideline which entail; rationale, objectives, duration, and the expected outcome of the curriculum accreditation guideline as highlighted here under;

2.2 Rationale of curriculum accreditation guideline

The Board conducts various professional trainings for awards and certification process, capacity building through continuous professional development programs, and tailor-made training to professionals and stakeholders in procurement and supply chain management. Management practices of conducting these programs depicted a paradigm shift in the profession from procurement and supplies to procurement and supply chain management. Hence, guidance to training institutions to incorporate core subjects and learning outcomes that cover the entire supply chain like procurement, supply, asset management, and logistics to bridge the gap for professional practices in public and private sector procuring entities is given.

Nevertheless, there is a need to standardize various programmes and awards in the procurement and supply chain profession as offered by training institutions in Tanzania as evidenced when reviewing various programs for validation purposes. Guidance on standardization of procurement and supply chain programs will lead to the improvement of programmes areas like programmes naming, staffing, the inclusion of professional certification and qualification of the trainers, and duration of programme in various procurement and supply chain programs.

Curriculum situational analysis conducted during the development of the professional curriculum depicted the shortfall of technical and leadership skills in performing and managing procurement and supply chain functions in the country. This was envisaged by adequate core professional subjects for procurement and supply chain management in most of the training institutions curricular in the country that calls for the need to address the problem.

The benchmarking was made with TCU and NACTVET with regard to guidance on quality standards for higher learning training institutions. The results from benchmarking showed that these two education authorities have put emphasis on training institutions to ensure their training programmes have adequate credits that suffice skills and quality standards. There was no direct guidance provided with regard to the number of professional subjects which are to be included in the programmes being validated.

Nevertheless, it was noted that the implementation of curricula for procurement and supply chain management in tertiary colleges and universities depicted to have more credits allocated in subjects which are not related to procurement and supply chain courses (non-core subjects) while there are inadequate credits and subjects allocated in procurement and supply chain courses (Professional Courses). In that regard, inadequate subjects in professional courses have necessitated the Board to guide tertiary colleges and universities in the standardization of programmes, awards and certification.

Also, the compliance inspection conducted in some procuring entities depicts unequal competencies of professionals performing procurement and supply chain functions in the country. This is vividly indicated by the PPRA and CAG reports that the Board analyses and shared the pitfalls with the professionals in procuring entities.

Moreover, harmonizing and providing professional guidance on professional procurement and supply chain management awards acquired outside Tanzania to embrace the Tanzanian professional context is paramount.

The guidance is with regard to uncovered local content related to procurement ethics and professionalism, in the Tanzania environment, legal framework governing procurement and supply chain in the country, public procurement procedures and effective management of procurement and supply chain management in the country.

2.3 Objectives of the Guideline

The curriculum accreditation guideline will be guided by the following objectives;

- (a) Standardise various programmes and awards in procurement and supply chain profession offered by training institutions in Tanzania.
- (b) Standardise competencies of procurement and supply chain graduates from training institutions.
- (c) Standardise trainers' qualifications and staffing level in procurement and supply chain management programs offered by training institutions.
- (d) Standardise training duration for procurement and supply chain management programs offered by training institutions in the country.
- (e) Equate equivalency and certification of professional qualifications for various procurement and supply chain professional programs from the professional institutes and other professional Boards.

2.4 Accreditation duration

Board accreditation is a continuous process, which is subject to a periodic review by each tertiary or higher learning training institution. Board's accreditation is renewable after every six (6) years. Institutions that have received Board's accreditation on their programs are required to process

for new accreditation after a lapse of five years, otherwise, their registration will be withdrawn by the Board.

2.5 Anticipated outcome

The successful implementation of this guideline is expected to result into:

- (a) Improved curricular design, development, and implementation in procurement and supply chain programs
- (b) Improved candidates' performance in professional examinations
- (c) Enhanced transparency for quality control and assurance in the procurement and supply chain profession
- (d) Enhanced regulatory control for quality improvement in procurement and supply chain profession.
- (e) Satisfaction with society's and stakeholder's interests, expectations, and needs;
- (f) Improved Boards' image in quality control of the profession, and thus enhanced relations with stakeholders.
- (g) Improved work performance of the graduates in procurement and supply chain programs.
- (h) Enhanced capacity for graduates to compete in the competitive labour market.

SECTION THREE

FRAMEWORK FOR VALIDATION AND ACCREDITATION

3.1 Introduction

This section provides a guiding framework for accreditation programs in procurement and supply chain courses for training programs in certificate, diploma, Bachelor degree, Masters programs and equivalency for professional awards as detailed here under;

3.2 Procurement and Supply Chain programs' Nomenclature and training duration

The Board has accredited the following nomenclature of the training programs in procurement and supply chain that can be adopted in higher learning training institution(s) in Tanzania when designing or preparing themselves to conduct training in the discipline of procurement and supply chain programs as highlighted here under;

(a) Certificate Programmes:

The following are accredited certificate programmes to be adopted by either tertiary or higher learning training institutions;

- (i) Certificate in Procurement and Logistics Management.
- (ii) Certificate in Procurement and Supply Chain Management
- (iii) Certificate in Procurement and Supply Management
- (iv) Certificate of Business Administration in Procurement and Logistics Management.
- (v) Certificate of Business Administration in Procurement and Supply chain management.

The Certificate training in procurement and supply chain programs can be run in full-time, part-time, and distance learning modes. The Board guides that the duration of the certificate program is a minimum of one year for fulltime and a maximum duration of two years.

(b) Diploma Program:

The following are accredited Diploma programmes to be adopted by either tertiary or higher learning training institutions.

- (i) Diploma in Procurement and Logistics Management.
- (ii) Diploma in Procurement and Supply Chain Management
- (iii) Diploma in Procurement and Supply Management
- (iv) Diploma of Business Administration in Procurement and Logistics Management.
- (v) Diploma of Business Administration in Procurement and supply chain management.

Diploma training in procurement and supply chain programs can be run in full-time, and distance learning modes. The Board guides that the duration of the Diploma program is a minimum of two years for full-time and a maximum duration of three years.

(c) Graduate Program:

The following are accredited Bachelor's degree programmes to be adopted by higher learning training institutions.

- (i) Bachelor in Procurement and Logistics Management.
- (ii) Bachelor in Procurement and Supply Chain Management
- (iii) Bachelor in Procurement and Supply Management
- (iv) Bachelor of Business Administration in Procurement and Logistics Management.
- (v) Bachelor of Business Administration in procurement and supply chain management.

Bachelor's degree training programs in procurement and supply chain programs can be run in full-time, and distance learning modes. The Board guides that, the duration of a bachelor's degree program can be a minimum of three (3) years for full-time and a maximum duration of six (6) years.

(d) Master's Program:

The following are accredited Master's degree programmes to be adopted by either tertiary or higher learning training institutions.

- (i) Master in Procurement and Logistics Management.
- (ii) Master in Procurement and Supply Chain Management.
- (iii) Master in Procurement and Supply Management
- (iv) Master of Business Administration in Procurement and Logistics Management.
- (v) Master of Business Administration in procurement and supply chain management.

Master's degree training programs in procurement and supply chain can be run in full-time, evening, or part-time and distance learning modes. The Board guides that, the duration of Master's degree programs can be a minimum of eighteen (18) months and a maximum duration of four (4) years. Equally, the duration of Professional Masters ranges from one year to a maximum of three years.

3.3 Mandatory Subjects in Institutions' Curricula

These accreditation guidelines require the institution to offer appropriate academic-level programmes in procurement and supply chain fields of study that culminate in identified student competencies leading to professional certification. The institution is therefore required to include in its educational programmes the following professional subjects which are key and necessary to be covered by students of each indicated level.

3.3.1 Certificate Program:

The accreditation requires at least four (4) core professional subjects to be included in any certificate program related to Procurement and Supply Chain Management for the purpose of

enhancing professional competencies at the respective level. The following three (3) core professional subjects are mandatory:

- (i) Principles of Procurement
- (ii) Warehouse and inventory principles
- (iii) Basics of Asset Management or Basics of freight forward

3.3.2 Diploma Program:

The accreditation requires at least six (6) professional subjects to be included in any Diploma program related to Procurement and Supply Chain Management for the purpose of enhancing professional competencies at the respective level. The following four (4) core professional subjects are mandatory:

- (i) Warehouse Operations
- (ii) Principles of Assets Management
- (iii) Fundamentals of Procurement Contract Management
- (iv) Tendering Process and Techniques

3.3.3 Bachelor/Graduate Degree Program:

(a) The accreditation requires at least 15 professional subjects to be included in any Bachelor's Degree program related to Procurement and Supply Chain Management for the purpose of enhancing professional competencies at the respective level. The following seven (7) core professional subjects are mandatory:

- (i) Procurement Management
- (ii) Warehouse Management
- (iii) Public Procurement Management
- (iv) Procurement Ethics and professionalism
- (v) Asset Management
- (vi) Inventory Management
- (vii) e- Procurement and supply management

- (b) Accreditation for Bachelor's degree programs with specialization in procurement and supply chain requires students in this profession to cover at least three core subjects in learning areas of procurement, supplies, and asset management for the two semesters of the first year.

The mandatory core subjects to be covered include;

- (i) Introduction to Procurement and supply chain management
- (ii) Warehouse management
- (iii) Legal aspects of procurement

This will enable students to be aware of the entire procurement and supply chain profession for specialization decisions in the second year and enhance professionalism.

3.3.4 Master's Program:

The accreditation guidelines require at least six (6) professional subjects and a Dissertation related to Procurement and Supply Chain Management to be included in any Master's Degree program related to Procurement and Supply Chain Management for the purpose of enhancing professional competencies at the respective level.

The following four (4) core professional subjects are mandatory:

- (i) Procurement Project Management
- (ii) Business Negotiation Skills
- (iii) Leadership and Governance
- (iv) Strategic Procurement and Supply Chain Management.

3.3.5 Professional training programs and Award

The Board will also validate professional awards in procurement and supply programs for the purpose of comparing equivalency, exemptions, and certification. The validation and accreditation of

the program will base on the analysis of content and learning outcome intended to be attained in the particular level of study.

The determined professional gap will be filled by respective graduates through acquiring professional training either conducted by training providers' institutions or training by the Board prior to qualifying professional examinations.

Besides the analysis, foreign professional awards will be subjected to review so as to determine the extent of coverage requirement based on the local content package in procurement and supply chain management. In that regard, local content will consider but not limited to the following areas: procurement ethics and professionalism, the legal aspect of procurement and supply, and Public procurement that will equally be attested through qualifying professional examinations prior to Boards' certification.

3.4 Trainers' qualifications

These accreditation guidelines require the institution to have sufficient numbers of qualified full-time and part-time staff, with appropriate professional qualifications, education, training, and experience, to effectively support its educational programmes and services wherever offered and by whatever means delivered.

It also requires an assessment of professional development such that trainers in Procurement and Supply Chain Management programmes from certificate to Master's degree must be registered by the Board and possess the following professional requirements:

(a) Certificate and Diploma Programs

Trainers for certificate and Diploma programs must be registered by the Board as Graduate Procurement and Supply Professional with a minimum of one year working experience for certificate and two working experiences in procurement and supply chain functions or training experience besides academic qualifications as guided by either TCU or NACTVET.

(b) Bachelor Degree/Graduate Program:

Trainers of the Bachelor's Degree program must be registered by the Board in at least an approved category with a minimum of three years of working experience practices in procurement and supply chain functions or training experience.

(c) Master's Program:

Trainers of the Master's Degree program apart from possessing appropriate education, training, and experience but must be holders of CPSP and registered as authorized Procurement and Supply Professional with a minimum working experience of five years in procurement and supply chain functions or training experience practices.

3.5 Clusters of program recognition for Exemption

The Board has classified training institutions which can seek and obtain accreditations for their Procurement and Supply chain programmes in lieu of exemption to the Boards' program and certifications provided that respective institutions' or clusters award conform to standards;

(a) Adopted College: means a college that is initially established independently but at a later stage it seeks to be fully guided by the university in terms of both the academic awards and approvals including academic staff promotion with exception of the other aspects of management of its resources that will be under the control of the respective governance organ as per the legal instruments that established the college. The graduates under such colleges in procurement and supply chain management will be validated for consideration of professional examinations' exemptions and certifications.

(b) Affiliated College: means an autonomous higher education institution accredited to offer degree programmes and confer degrees on behalf of an accredited university.

(c) **Associate College:** means a college established independently under its enabling legal instrument that seek and obtain the university's participation in its academic programme or programmes in terms of professional and academic guidance and supervision to ensure that the college operates at a level appropriate to its own statutory object or purposes and functions with the view to raising and upholding the standards of the college and heightening its status and prestige, but does not seek to participate in any programme of the university nor to attain the level of standard of the university.

(d) **Autonomous Campus, Institute or School:**

An academic unit of a college or university that has been established by a legal instrument of a university that has the same characteristics and performing similar functions related to a college or university.

(e) **Campus Institute:** means a non-autonomous governance unit within the premises of or in close proximity to a university established by a legal instrument of a university.

(f) **Campus School:** means a non-autonomous governance unit within the premises of or in close proximity to a university established by a legal instrument of a university and such an institution may also be established in respect of an autonomous institute or centre.

(g) **Connected College:** means an autonomous institution empowered to offer university level education which depends on the university to which it is affiliated for the approval and validation of its academic programmes, courses and awards including student entry qualification, course syllabi and examination rules.

(h) **Constituent College:** means semi-autonomous institution established and empowered to offer university level education placed under the tutelage of a university including a foreign

university, for nurturance with a view to its establishment as an independent university

- (i) **Directorate:** means a non-autonomous governance unit within the premises of or in close proximity to a university established by a legal instrument of a university and such an institution may also be established in respect of an autonomous institute or centre.
- (j) **Faculty:** means a non-autonomous governance unit within the premises of or in close proximity to a university established by a legal instrument of a university and such an institution may also be established in respect of an autonomous institute or centre.
- (k) **Unit:** means a non-autonomous governance unit within a College, School, Faculty, Directorate, Department or Campus centre established by a legal instrument of a university and such an institution may also be established in respect of an autonomous institute or centre.
- (l) **University:** means an institution which offers a level of education and training that leads to intermediate and full academic or professional qualifications and competence namely certificate, diplomas, degrees and master's programs.
- (m) **Professional Board and institute**

These are professional institutions offering professional training programs and awards in procurement and supply chain management like Chartered institute of purchasing and supply (CIPS), Kenya institute of supplies management, etc.

This will enable students to be aware of the entire procurement and supply chain profession for specialization decisions in the second year and enhancing professionalism.

3.6 Competence Description in Procurement and Supply chain programs

Competence descriptors is described as the minimum level of learning experience it takes to produce work of acceptable quality to meet the standards of the profession. Hence, the emphasis should gear towards producing graduates with adequate relevant competencies who can perform procurement and supply chain duties in the real working environment.

The Board will focus on adherence to set minimum units, credits and weight to core subjects in procurement and supply chain profession. This to meet the intended learning objectives and outcome of nurturing and producing capable graduate to suit the field professional practice in procurement and supply chain functions.

SECTION FOUR

MONITORING AND EVALUATION

4.1 Introduction

The Board will conduct monitoring and evaluation in training institutions to share feedback, and experiences and get insight into the curriculum implementation in procurement and supply chain programs to enhance the quality of the graduates.

4.2 Monitoring and Evaluation Procedures

Monitoring of the curriculum is expected to be a continuous process of collecting and analyzing information about the procurement and supply chain programs in comparing the actual situation of the program against planned results in order to judge how well the intervention is being implemented.

Evaluation will be conducted annually or at intervals of three years to assess all the elements of a program including the curriculum implementation process and results achieved, making professional advice to training institutions and the competent education authority on professional practice trends and professionalism to identify ways to achieve more desired results for quality enhancement of procurement and supply chain programs.

The Board shall conduct an evaluation to measure compliance with the requirement determined by the Board for the provision of procurement and supply chain education and training at least once every year or at intervals as may be determined by the Board from time to time.

The data will be generated by the program on the basis of compliance level for implementation of professional issues issued under this guideline. Monitoring and evaluation will be conducted on the modalities of Physical visits to training institutions, curricular review, online conversation, sharing the experience with the management, conducting awareness to Bonafede students of colleges and universities informing update on the professional practices to determine competencies required in the real working environment.

SECTION FIVE

CONCLUSION

Curriculum Accreditation Guideline is essential in safeguarding the standard of procurement and supply profession and the global professional standard practices. The Guideline is delimited to all training institutions offering procurement and supply courses in the United Republic of Tanzania in order to produce standard and competent graduates both Public and Private training institutions.
